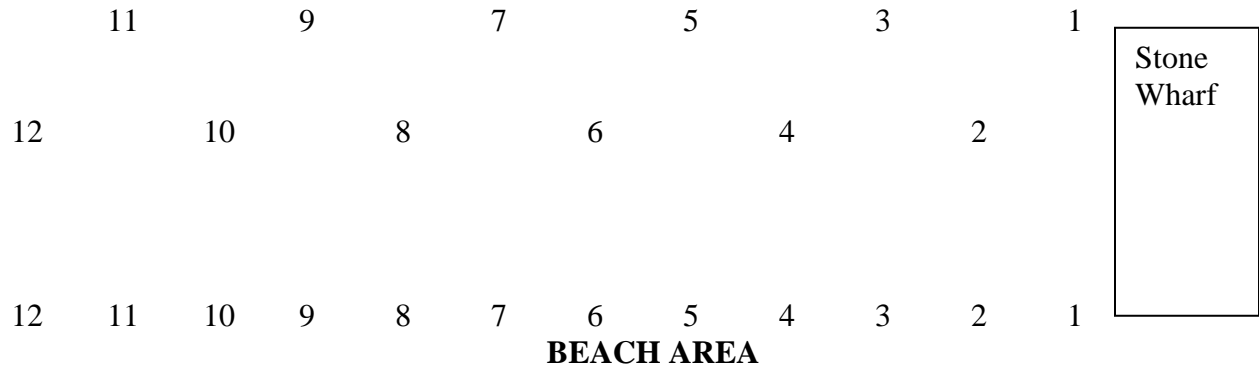


West Wharf Mooring Posts Rental Regulations

- Permanent Madison residents and property owners assessed at \$1,000 or more may apply.
 - Vessel must be registered in the name of the resident or taxpayer in order to be eligible.
- Application (Page 2 of this document) for a mooring post must be submitted by March 31, 2012.
- A computer spin lottery will take place on Friday, April 6, 2012 at 9:30 a.m. Notification will follow thereafter.
- Permits are nontransferable and are nonrefundable.
- Only one application will be accepted per family.
- Mooring posts will be rented to boats of 14 to 18 feet in length only.
- Rental fee is \$220.00
- **A check made payable to the Town of Madison, and a copy of your current State of Connecticut Registration Certificate must accompany your application.**
- Your boat must display a Town Boat Number, issued by the Recreation Office, on the stern before you place it on the mooring post and must continue to display this number throughout the boating season. There is no cost to obtain a Town Boat Number.
- Boat owners will need approximately 225' of rope along with a pulley to moor the vessel.
- The mooring permit covers the period from date of issuance to November 30, 2012. All ropes and pulleys must be removed as of this date.
- **Posts that remain vacant as of June 30th (unless department has prior written document requesting extension of vacancy) will be considered open and shall be issued out to the next person on the waitlist.**
- The Madison Beach and Recreation Commission, the Recreation Director, or the Police Department may, at their discretion, revoke any mooring permit upon misuse of it or misconduct on the part of the holder.
- The Recreation Department or the Town of Madison is not liable for vandalism or other damage done to boats stored on Town property.
- Boats confiscated due to violation of these regulations will be returned after the owner pays the cost of removal, plus \$20 to the Recreation Department.
- In order to help ensure public safety in this area, please abide by the following regulations while utilizing your boat.
 - No wake within the anchorage area (visual line from the end of the wharf to round rock by Tuxis Island).
 - Please stay way from private beach areas (East of white fence).
